It was RESOLVED to remove the wooden posts on the mound.

It was RESOLVED to level the sides of the mound and install grass matting where required and reseed.

Members discussed suggestions for the renewal of the mini golf area.

It was RESOLVED obtain quotes for the refurbishment of the mini golf area.

# 10. Dronfield Woodhouse Play Area
