## MINUTES OF THE ORDINARY MEETING OF DRONFIELD TOWN COUNCIL HELD IN THE COUNCIL CHAMBER, CIVIC HALL, DRONFIELD ON MONDAY 3<sup>RD</sup> NOVEMBER 2014

#### **Present:**

#### 2 Declarations of Interest

Councillors J Allsop and S Allsop declared a pecuniary interest in agenda item 5 - Planning Application number 14/00901/FL, Land to the rear of 14 to 22 Green Lane and 4 to 6 Park Avenue, being owners of neighbouring property.

Councillor C Smith declared a personal interest in agenda item 5 – Planning Application number 14/14/009/TPO works to various trees, Dronfield Cemetery being a member of the Burial Committee.

Councillor R Hall declared a personal interest in agenda item 5 – Planning Application number 14/14/009/TPO works to various trees, Dronfield Cemetery being a member of the Burial Committee

#### 3 Public Speaking

#### 3a Planning matters

Councillors J Allsop and S Allsop left the room and Councillor A Talford took the chair.

Planning Application number 14/00901/FL, Land to the rear of 14 to 22 Green Lane and 4 to 6 Park Avenue.

Significant concerns and objections were raised regarding the design and layout of the plot and the access to it. The proposed houses are too big, too high and not in keeping with the area. There are two proposed routes of access and the one from Green Lane is potentially dangerous. It is 45m away from the school and from a pedestrian crossing. More traffic would mean more congestion and danger to children pedestrians and cyclist. Henry Fanshawe School use the footpath to reach the playing fields. The access statement is incorrect on the entrance from Green Lane and does not agree with the site plan. The Town Council are requested to object to this application.

It was RESOLVED to suspend Standing Orders to allow more members of the public to speak beyond the time limit.

Councillors J Allsop and S Allsop re-joined the meeting and Councillor S Allsop re-took the Chair.

Planning Application number 14/00962/FLH, Addition to first floor with new pitched roof to existing bungalow.

Concerns and objections were raised that the proposed addition would be too high and too big and would affect nearby properties, it is nearly twice as big as nearby properties. Access is restricted as Oxclose Drive is only 2.4M wide. There has been no application for demolition

#### Standing Orders were re-instated

#### 3b General Matters

A question was raised regarding Street naming and numbering and the meeting was informed that these were sent by Building Control at North East Derbyshire District Council.

Concerns were raised regarding speeding traffic on Snape Hill Lane and the question was asked if traffic could be monitored or other measures investigated. There are no traffic calming measures and more traffic uses Snape Hill Lane because of this. Cars cut the corner at the junction with Green Lane which is dangerous. Speeding traffic is affecting the lives of residents.

#### 3c Police Matters

PC A Stones attended the meeting and the new format written report had been circulated to Councillors.

Violent crimes were down in October; A suspect has been identified for the robbery incident; Burglary of dwellings is still of concern but two suspects have been arrested and charged; There were eight shed burglaries in October.

An increase in thefts is expected as the clocks go back and there is a longer period of darkness. Advice is being given to home owners and information packs are being left at houses where no lights are on.

A request was made for the speeding on Snape Hill Lane to be investigated by the Police and Derbyshire County Council Highways to look at the layout of the road. The Police are promoting community speedwatch. Four speed guns have been ordered and volunteers will be trained to operate them without the need for Police presence. One will be available for use in Dronfield.

#### 134/14-15 RESOLVED

It was resolved to request County Councillor Janet Hill to ask officers to come and have a look at Snape Hill Lane and the junction with Green Lane.

Dronfield Town Council OBJECTS to this application on the grounds that it is out of keeping with the area and that the access on to the footpath is unsuitable. A site meeting with the Planners and Derbyshire County Council Highways will be requested. This application has been objected to in the past.

Councillors J Allsop and S Allsop re-joined the meeting and Councillor S Allsop re-took the Chair.

<u>Planning Application number 14/00962/FLH, Addition to first floor with new pitched roof to existing bungalow.</u>

Dronfield Town Council OBJECTS to this application on the grounds the proposed addition is too large, overlooks nearby houses and the road is too restrictive for construction traffic.

<u>Planning Application 14/1076/FL Erection of a single storey extension with basement to the rear of Dronfield Hall Farm</u>

More information is required.

Planning Application 14/00791/FL Installation of 16.5M high monopole mast

The following tasks have been carried out during the month of October

Litter Bins - The Dog and Litter bins continue to be emptied on a weekly basis.

Play Areas - Maintenance continues on the play areas.

Flower Beds – All the flower beds have been rotovated and winter bedding plants (7100) have been planted in all flower beds apart from the one outside the White Swan, this is due to us trying to eradicate the chick weed that grows in this bed, we will rotovate and spray a couple of times over the coming months to try to kill the chick weed.

<u>Footpaths</u> - Maintenance has taken place on the footpaths. All footpaths that DTC maintain have been strimmed back and cleaned of any weeds. We will be carrying out shrub maintenance in the areas that require cutting back over the next few weeks with the use of the new shredder/chipper.

<u>Grass Cutting</u> - Grass cutting continues hopefully the last cut should be done in the next week or two. The mild weather is making it difficult to say when we will finish grass cutting as it seems to be still growing for this time of year.

<u>Cemetery</u> -The team have been in the cemetery maintaining all areas, all the grass areas are being cut and strimmed, the baskets are emptied on a Monday and Friday, and the toilets cleaned twice a week. At present we are trying to blow the leaves from all footpaths so the public can still access areas within the Cemetery, We are waiting to see if a litter/leaf sucker will be purchased for the use in the cemetery which will help to pick up the leaves and shred them, as this would take the team a lot of time to try and do by hand.

<u>Coal Aston Football Pavilion.</u> - We now have a new cleaner whom has started working for DTC, and he has been working at Coal Aston Football Pavilion over the last couple of weeks giving the shower rooms a good deep clean as well as opening/closing the changing rooms for the football at weekends.

<u>Hilltop</u> – British Coal have been back to the area at Hilltop W/C 27/10/14 to start the follow on works with the capping of the hole.

<u>Bowling Clubs</u> – The end of season works have been carried out on the bowling greens. Maintenance work will continue till the start of season.

<u>Xmas Lights</u> – Testing all lights, repairing where required, in preparation for next month. Other
