5b General Matters continued

John Harvey resident of Lea Road spoke in respect of the report of the Road Safety Advisory Committee and the request from a resident for further traffic calming; the report refers back to the 2010 minute with parked cars preventing traffic from moving quickly. As an observer he considers that the parked cars are seen as a challenge to get through quickly and therefore encourage faster driving. Traffic calming is unpopular and £90,000 has been spent on calming schemes; the evidence is that speed is marginally reduced when 20mph zones and traffic calming are integrated. He request that the Committee look at the 20's Plenty national campaign to reduce speed limits in urban residential areas to 20mph.

PCSO Mark Karim attended the meeting and presented the written report; he highlighted that there are a number of packs of anti-theft number plate screws for residents to collect from the Police Station on Lea Road.

5d Dronfield U3A

Rob Brennan of the U3A addressed the meeting. The U3A commenced in France in 1972 and came to Britain in 1981; creating a provision for more elderly people to teach each other via a freely given service. The Dronfield U3A was launched in October 2013 and at the end of March had approximately 180 members. They used the Shaun Hadley Room and Council Chamber for various meetings; with a large monthly meeting held in the Civic Hall. Their costs are roughly one third room hire, one third to the central body and one third on general running including speakers and printing etc. The U3A is providing a service to older people in Dronfield and a request is made for Council support.
