Damage offences at Coal Aston continue, 5 during April. A leaflet drop of residents is planned using Police Service Volunteers. We are avoiding broadcast media as after months of the problem being confined to Coal Aston, we are getting similar offences in Dronfield and Unstone and are concerned that we have copycat offences.

Shoplifting is the other problem, with a spate at Co-ops (5), Aldi and Sainsburys. The offenders are largely known and from South Yorkshire area – arrests are pending. Sally is now visiting Woodseats Police Station monthly to share information and encourage cross border co-operation.

Apologies for our non-attendance, we will resume normal service next month.

#### 9 Outside Services Report

The following tasks have been carried out during the month of April.

Litter Bins - The Dog and Litter bins continue to be emptied on a weekly basis.

<u>Play Areas</u> - Maintenance continues on the play areas. The fencing at Hilltop Play area has been fixed and metal banding used to secure the fencing back onto the posts.

Cemetery - The baskets are emptied on a Monday and Friday, and the toilets cleaned twice a week

<u>Bus Shelters</u> – All the shelters have been cleaned and any debris removed from inside and around the shelters.

<u>Footpaths</u> - The footpaths that are looked after DTC all been litter picked and any debris removed. They have also all been strimmed and any overhanging shrub/bushes have been cut back

<u>Coal Aston Changing Rooms</u> – The changing rooms are cleaned on a Monday and Wednesday after the football at the weekend and week day games.

<u>Flower beds</u> – The flower beds have all been maintained with the beds turned over and all weeds removed.

<u>Grass Cutting</u> - The grass cutting around all DTC owned areas continues and will be cut on a fortnightly basis. All the perimeters around the parks are also being strimmed.

<u>Cemetery</u> – The grass cutting continues within the Cemetery and this is cut on a fortnightly basis the week after DTC areas have all been cut.

<u>Hilltop Play area</u> – The ground works has now been completed with new soil infilling where the old tarmac and soft surface was and grass seed has been sown. Once the grass has been established we will be able to start the installation of new play equipment.

Beacon Lighting – The Beacon lighting took place on 21st April, all went as planned and there was a good turnout for the event.

<u>Tree Works</u> – Some tree works has been done, in Cliffe Park a weeping willow has been removed as this had shown signs of decay at the base of the tree and had died. There has been some work also done at the back of Alma to reduce and remove some broken branches and trees.
