1 Town Council Standing Orders

2 Police Matters

Inspector Shooter presented the crime figures for February 2012 as follows:

Damage 4 Fraud 1 Other theft 9 Theft from Motor Vehicle 3 Drugs Possession 3 Robbery 1 Non Dwelling Burglary 4 Dwelling Burglary 2 4 ABH Common Assault 1

Crime has almost halved in February compared to January, there were 34 crimes in February. The most serious crime was a robbery; the offender has been charged with the offence. There have been six burglaries; one had electrical items stolen, two were attempts, two were damage to a disused property and the remaining burglary resulted in electrical items being stolen. Three vehicles were attacked; two for electrical items and the other for tyres. There is a trend at the moment on the division where vans are being attacked and power tools stolen. The key issue in the area at the present time is the theft of scrap metal and members of the public are asked to ring the police if any scrap metal dealers are in the area.

Inspector Shooter updated the meeting on the closure of the Police Enquiry Office, there has been a need to re-design services to make financial saving and this has so far been achieved without cuts to front line services. There are a number of methods for members of the public to contact the police including the Safer Neighbourhood Team Forums, phone and email. It was categorically stated that the Police Station is not closing. The comparative data that the Council has requested is being compiled.

Congratulations were given to Inspector Shooter on reaching the grade of Chief Inspector.

It was agreed that the Council would re-iterate objections outlined at the meeting of 3 January 2012 to the amended planning application 11/01103/FL – Application for the construction of 5 detached dwellings with integral garages (revised scheme of 11/00361/FL) (Amended Plan) at Land to the Rear of 14 to 22 Green Lane and 4 to 16 Park Avenue. Members feel that this proposal is unsuitable on this site. The proposal is a back land development for five huge houses. The houses are out of scale with the existing houses in the area. The proposal is on a green field site in the heart of Dronfield, the land was set aside for vegetable gardens and a paddock. It is strongly felt that the building of these dwellings would have a detrimental effect on the area on neighbouring properties. It is requested that a site visit is carried out prior to assessing this application and that the application is considered by the Planning Committee.

It was agreed that the Council would object to planning application 12/00068/FL – Erection of two detached dwellings with attached double garages and extension of existing private drive including demolition of existing walling and garden store (Conservation Area)

The proposed development is in the conservation area and is back land development. The houses are out of scale with surrounding properties. There are concerns over loss of habitat for wildlife and concerns over access to the site. It is requested that a site visit is carried out prior to assessing this application and that the application is considered by the Planning Committee.
