4 Code of Conduct

Councillors received a brief presentation and considered the adoption of the Code of Conduct as received from North East Derbyshire District Council

To amend Standing Order 7:

From:

"7.1 All councillors shall observe the code of conduct adopted by the Council.

7.2 All councillors shall undertake training in the code of conduct within 6 months of the delivery of their declaration of acceptance of office.

7.3 If paragraph 12(2) of the code of conduct contained in the Local Authorities (Model Code of Conduct) Order 2007 (SI No.1159) has been adopted by the Council or pursuant to relevant provisions in a statutory code of conduct in force at the time, councillors may exercise the rights contained in standing order 7(d) below only if members of the public are permitted to (i) make representations, (ii) answer questions and (iii) give evidence relating to the business being transacted.

7.4 Councillors with a prejudicial interest in relation to any item of business being transacted at a meeting may (i) make representations, (ii) answer questions and (iii)

give evidence relating to the business being transacted but must, thereafter, leave the room or chamber."

To:

"7.1 All councillors shall observe the code of conduct adopted by the Council.

7.2 All councillors shall undertake training in the code of conduct within 6 months of the delivery of their declaration of acceptance of office.

7.3 Where a member has a disclosable pecuniary interest in any business of the authority they must withdraw from the meeting room (including the public gallery) whenever it becomes apparent that the business is being considered, unless the member has been granted a dispensation from the District Councils Monitoring Officer.

7.4 Where a member has a significant other interest in any business of the authority they must withdraw from the meeting room (including the public gallery) whenever it becomes apparent that the business is being considered.

7.5 A member with a significant other interest in any business of the authority may still attend that meeting but only for the purpose of making representations, answering questions or giving evidence relating to the business, provided that the public are also allowed to attend the meeting for the same purpose. Immediately after making representations, answering questions or giving evidence the member must withdraw from the meeting room (including the public gallery) for the consideration and vote on the business."

7 Multi User Games Area

Councillors received the details of the RoSPA inspection carried out on the 3 July 2012. There are a number of issues with both the fencing and surfacing that need to be addressed. The fencing issues have been rectified in house this week and the Contractor is due to carry out a quotation for works required to the surfacing.

Councillors received details of the income being lost through the closure and the inherent problem of the potential loss of users.

The planning application was objected to on the grounds of nuisance to local residents, light pollution and noise up to 9.30pm in the evening. There were also concerns that this would exacerbate parking issues in the area.
