1. Apologies

Apologies were received from Councillors A. Foster, R. Gilmore, R. Hall, M. Ireland, P. Parkin and R. Spooner.

4. Public Speaking

4.1 Planning matters

There were no comments on planning matters.

Six members of the public spoke about a proposal to build a pump track in Sindelfingen Park, three spoke in support of the proposal and three spoke against the proposal.

Members were informed that one application had been received for the available position and the candidate qualified to stand as a councillor.

Councillors M. Foster, A. Powell and L. Deighton declared a non-pecuniary interest as they sit on the planning committee at NEDDC and therefore did not participate in the discussion and abstained from the voting.

The Town Clerk brought planning application 21/01013/CATPO to the attention of the council as it is on land belonging to the Town Council at Lucas Gardens.

That there was a consensus that the works described under planning application 21/01013/CATPO can be undertaken.

Cllr A. Dale proposed the council object to planning application 21/00843/FL on the grounds that there continues to be safety concerns regarding school children and park users due to the proposed level of development on this site and that it could be considered an overdevelopment of the site and there are questions over whether the plans are in keeping with the area.

That the Town Council write to NEDDC to object to planning application 21/00843/FL on the grounds of safety, overdevelopment of the site and in keeping with the area, with the letter to be agreed by Cllr Dale before it is sent.

Cllr Dale spoke about planning application 21/00934/TCN56 for a proposed monopole, cabinet and associated works and proposed the council object on a number of grounds including it being in a conservation area, the site sits at a lower level than some housing in the area and would interfere with a grade II listed building.

9. Outside Services Report

The following tasks have been carried out in July and up to 13th August 2021.

Litter/Dog Bins - The litter and dog bins continue to be emptied on a weekly basis, this is carried out every Thursday and consists of 2 men doing the whole route.

The emptying of dog bins on a Monday around the Golf course and Hilltop area has now been added to the daily task carried out on a Monday morning.

A visual inspection of the play areas/equipment is carried out at the same time. Anything that is picked up on the Visual inspection is entered into the Play Area Inspection folders for each area when staff returns back to the workshop. Items that can be rectified by O/S staff will be repaired, if we have the parts before the next visual inspection takes place.

Cemetery - The baskets are emptied around the Cemetery on a Monday and Friday.

Litter Picking – All Parks and Open spaces have been litter picked including around all hedgerows.

Grass Cutting – Outside Services staff are now cutting all DTC open spaces, parks and children's play areas on a fortnightly basis.

Cemetery Grass Cutting – The Cemetery grass areas are being cut on a fortnightly basis the week after cutting DTC grass.

Coal Aston Tennis Courts – The tennis courts are now open for members of public to play. We have had a bit of damage done to one of the nets where it has been cut; this was one week after the courts had opened.

Hanging Baskets – The baskets are being watered on a weekly basis. Whilst out watering the baskets we also help out by watering both the ladles, opposite Coach and Horses and opposite Three Tons Pub. Some of the hanging baskets are starting to wilt a little but this is due to Outside Services not having a vehicle to install the water tank we use for filling the baskets due to recent break-in.

Flower Beds – The flower beds have been deweeded as we had a lot of chickweed growing in the beds.

Wildflower Meadows – The wild flowers meadows at both sites, Sindlefingen Park and Hilltop are growing well. The beds at Hilltop have been cut back, this was carried out by the contractor Pictorial Meadows due to there being a lot of weeds growing in both beds and they have said that the perennial flowers will soon grow back.

Cliffe Park – The grounds and hedgerows around the park were all cut in preparation for the Gala, some bollards have been installed to prevent the public from parking on the grass verges. The area is cut back on a fortnightly basis.

Church Street Car Park – The area around the car park with overgrowing shrubbery has been cut back and all self-planters have been removed. The back of the car park has been cleared to enable a bit more parking space. The work was carried out so that the car park can now be marked out with 10 bays on back edge and 3 spaces either side of the entrance with the first ones on each side being disabled parking. The car park is due to be lined in September.

Tree Maintenance – Underwoods Tree Surgeons have carried out works to the trees situated at Barnard Avenue, all reduction works and removal of dead wood has been completed.

Dronfield Gala – The preparation and marking out for the gala was carried out by O/S in the week running up to the Gala Sunday 25th July. The Gala was set up and ready to open at 12.00hrs on the day. The weather was fair and was very busy and well attended. Everyone seemed to be having a good time and there was plenty of rides and stalls for all ages to enjoy. The area of Cliffe Park was cleared and left clean and all equipment stored in the workshop by 18.00hrs.

Workshop Unit – On 27th July at 19.50hrs the workshop was broken in to. All the Stihl garden machinery was taken along with two vehicles. This has had an impact on how Outside Services were able to carry out their tasks as we had no transport or machinery, we managed to carry on with the grass cutting as the lawn mowers were not stolen. It took a bit of time to get the new roller doors installed but two storage containers from Banner Plant were placed one on top of each other to secure the main entrance whilst waiting for the new roller door. We have managed to hire two vehicles to enable us to catch up with various tasks around the Town. Craig Fletcher loaned us a vehicle on both Thursdays after the break in to allow us to carry on with the emptying of dog and litter bins in our parks.

Play Areas

We are in the process of reinstalling all the swings that were taken down due to social distancing.

Birches Fold – two new benches have been installed around the play area.

Cliffe Park – The seesaw is still out of action, Creative Play is to attend site and rectify in September.

Moonpenny Way – Refurbishment to park has started and is expected to be completed by Friday 27th August

Sindlefingen Park – The zip wire and basket swing are due to be repaired 23rd August 2021.
