3 - Everything you need to know about... us!

As new (and not so new) councillors take their seats on parish and town councils across Derbyshire, we've put together a new online leaflet to explain exactly what DALC does, and what we offer. 4 - Updated councillor's guide to employment

Being a good employer is an essential part of a councillor's role, as it helps councils deliver better services for their communities. 6 - .gov website lookalike – beware!

Several of you have been in touch regarding a website which copies the style and format of official government sites, and has offered subscriptions for council directory listings. Subject of an investigation by Radio 4's consumer programme You and Yours (the clip can be heard here – report starts at 29:22), Parish.uk has caused consternation throughout the sector, with a number of clerks reporting that emails have urged local businesses to pay for directory listings. We encourage caution when dealing with any approach from this website!

7 - Councillor 'sign-up' rules

As you know, part of the post-election process is that councillors need to sign their 'acceptance of office' declaration. Ideally, this should take place at or before the first meeting after the election. However, if councillors are unable to do this, legislation allows the signing to happen at a later meeting fixed (that is, agreed and minuted) by the council. Once signed in the presence of another councillor or the clerk, the declaration is valid for the four-year period. Members are reminded that councillors who are elected Chair must sign and deliver a separate acceptance of office, and that this is an annual declaration. Again, Council can permit the declaration to be signed at an agreed later date.
